RESOLUTION NO. SF. 1396 S-2000

A RESOLUTION URGING THE HONORABLE ISMAEL A. MATHAY JR., CITY MAYOR, QUEZON CITY, TO ALLOCATE/APPROPRIATE THE SUM OF ONE MILLION SIX HUNDRED THIRTY THOUSAND FOUR HUNDRED THIRTY-FIVE PESOS (P1,630,435.00) FOR THE ASPHALTING OF JASMIN, LOWER EVERLASTING, AND PALMERA STREETS LOCATED IN BARANGAY PAYATAS, QUEZON CITY, FROM THE COMMUNITY DEVELOPMENT FUND OF THE CITY'S ANNUAL BUDGER FOR THE YEAR 2000.

WHEREAS, Jasmin, Lower Everlasting, and Palmera Streets in Barangay Payatas are rough roads which do not only cause inconvenience, but also pose hazard both to the commuters and barangay inhabitants traversing thereon;


WHEREAS, in a 1st Indorsement dated February 16, 1999 of Engr. Alfredo M. Macapugay, City Engineer of Quezon City, the amount of One Million Six Hundred Thirty Thousand Four Hundred Thirty-Five Pesos (P1,630,435.00) is recommended for the asphaltting of the streets aforestated;

WHEREAS, to ensure the safety and protection of the constituents, a concrete step should be taken to avoid the impending danger;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable Ismael A.
