RESOLUTION NO. SP-1398, S-2000

A RESOLUTION RATIFYING VARIOUS CONTRACTS MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, AS FIRST PARTY AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE, REPRESENTED BY ANGELITA K. BARRIENTOS, AS THE SECOND PARTY FOR THE REPAIR AND IMPROVEMENT OF TWO (2) YAKAP CENTERS AND HEALTH CENTER ALL LOCATED IN QUEZON CITY.

WHEREAS, after proper negotiations, the Quezon City government, represented by His Honor, Mayor Ismael A. Mathay, Jr., executed a contract with Angelot Construction and General Merchandise, represented by Angelita K. Barrientos, for the repair and improvement of Yakap and Health Centers all located in Quezon City, referred to in the following contracts:

- Annex "A" - Proposed Repair of Yakap Center, Quezon City Hall Compound
- Annex "B" - Proposed Improvement of Health Center located at Brgy. Culiati, Q.C.
- Annex "C" - Proposed Repair of Yakap Center (Phase I)

WHEREAS, the said contracts are valid and legal in all respects and may be ratified by the City Council;


NOW, THEREFORE,
