RESOLUTION NO. SP-1400 -S-2000

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO DISPOSE TO QUALIFIED BENEFICIARIES THE TWO (2) MEDIUM-RISE BUILDINGS COMPRISING OF SIXTY (60) UNITS CONSTRUCTED BY ANDREWS-GONZALES CONSTRUCTION CORPORATION, LOCATED AT PUD SITE, BARANGAY ESCOPA III, QUEZON CITY.

WHEREAS, the Quezon City government, consciously aware of the pressing needs for decent and economically affordable housing needs of families displaced by the C-5 road in Project 4 constructed socialized housing units at PUD Site, Barangay Escopa III;

WHEREAS, because of its location as a prime property, there is a need to maximize its utilization and transform its blighted condition into a model community;

WHEREAS, the said housing project has long been the commitment of the City government to its homeless employees and constituents;

WHEREAS, there is an immediate need to more vigorously implement the program and dispose the units to qualified beneficiaries;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ismael A. Mathay, Jr., to dispose to qualified beneficiaries the two (2) medium-rise buildings comprising of sixty (60) units constructed by Andrews-Gonzales Construction Corporation, located at PUD Site, Barangay Escopa III, Quezon City.

RESOLVED, FURTHER, that an Ad Hoc Committee be created to process the awarding of the units to qualified beneficiaries to be composed of the following:




