RESOLUTION NO. SP-14041, S-2000

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO ENTER INTO A CONTRACT OF LEASE WITH ISIDORA HILLS HOMEOWNERS ASSOCIATION, INC., AND UNANG LINGAP KAPWA, INC., INVOLVING A PARCEL OF LAND INTENDED AS AN OPEN SPACE OF THE ISIDORA HILLS HOMEOWNERS ASSOCIATION, INC., REGISTERED IN THE NAME OF QUEZON CITY UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED 141285 ISSUED BY THE REGISTRY OF DEEDS OF QUEZON CITY, FOR THE USE OF THE UNANG LINGAP KAPWA, INC., AS SITE OF ITS PROPOSED MEDICAL CLINIC, OFFICE AND TRAINING CENTER.


WHEREAS, the Unang Lingap Kapwa, Inc., plans to put up a sub-center office building to be used as skills/livelihood training center and medical clinic for the benefit of the indigent community;

WHEREAS, the Unang Lingap Kapwa, Inc., solicited the assistance of the Quezon City government for the use of a portion of a parcel of land registered in the name of Quezon City under Transfer Certificate of Title Numbered 141285 intended as an open space for the Isidora Homeowners Association, Inc.;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ismael A. Mathay, Jr., to enter into a Contract of Lease with Isidora Hills Homeowners Association, Inc., and Unang Lingap Kapwa, Inc., involving a parcel of land intended as an open space of the Isidora Hills Homeowners Association, Inc., registered in the name of Quezon City under Transfer Certificate of Title Numbered 141285 issued by the Registry of Deeds of Quezon City, for the use of the Unang Lingap Kapwa, Inc., as site of its proposed medical clinic, office and training center.
