RESOLUTION NO. SP- 1407, S-2000

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO ACQUIRE THE ONE HUNDRED EIGHTY-NINE SQUARE METER AND SEVENTY-FIVE SQUARE DECIMETER (189.75 SQ.M.) LOT COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-104358, AND LOCATED AT LIZARDO STREET, OR ANY EQUIVALENT LOT FOR THE CONSTRUCTION OF A BARANGAY HALL FOR BARANGAY DIOQUINO ZOBEL.

Introduced by Councilors JORGE L. BANAL and JULIAN M.L. COSETENG.

WHEREAS, the present barangay hall of Barangay Dioquino Zobel is on a lot privately owned by Mrs. Luzviminda C. Sausano and presently the subject of a foreclosure proceedings by the Metropolitan Bank and Trust Company to which it was mortgaged by the owner;

WHEREAS, a representative of the mortgagee bank had approached Barangay Chairman Redencio Nicandro concerning the imminent takeover of the bank and ownership of the lot;

WHEREAS, the Barangay Council of Barangay Dioquino Zobel has passed a Resolution "Requesting the Honorable Ismael A. Mathay, Jr., City Mayor, and Honorable Members of the City Council for the procurement of a lot for the construction of a Multi-Purpose Hall for Barangay Dioquino Zobel;"

WHEREAS, according to the Barangay Resolution a One Hundred Eighty-Nine square meter and Seventy-Five square decimeter (189.75 sq.m.) lot on Lizardo Street, a few meters from the present Barangay Hall is an appropriate site for a barangay multi-purpose hall;


NOW THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mathay, Jr., City Mayor, to acquire the One Hundred Eighty-Nine square meter and Seventy-Five square decimeter (189.75 sq.m.) lot covered by Transfer Certificate of Title Numbered RT-104358 located at Lizardo Street, or any equivalent lot for the construction of a barangay hall for Barangay Dioquino Zobel.
