RESOLUTION NO. SP-7414, S-2000

A RESOLUTION AUTHORIZING HIS HONOR, MAYOR ISMAEL A. MATHAY, JR., REPRESENTING QUEZON CITY, TO EXECUTE AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BARANGAY OF TANDANG SORA, REPRESENTED BY THE HONORABLE PUNONG BARANGAY SABINO A. APO, ALLOWING THE USE OF A PORTION OF A CITY-OWNED PARCEL OF LAND TECHNICALLY DESCRIBED UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED RT-21706 (246722), WHERE THE PROPOSED TWO-STOREY BANLAT HEALTH CENTER BUILDING WILL BE ERECTED.

WHEREAS, the Quezon City government is the registered owner of that certain parcel of land located in Barangay Tandang Sora, Quezon City, which is technically described and bounded under Transfer Certificate of Title Numbered RT-21706 (246722) of the Quezon City Land Registry;

WHEREAS, found constructed on the said parcel of land is an old and dilapidated building exclusively used by the Quezon City Health Department as Banlat Health Center where public health services are being dispensed;

WHEREAS, the continued use of the said building which is already in the state of disrepair and deterioration poses imminent danger to the lives and limbs of both patients and the medical staff and other health personnel;

WHEREAS, to avoid any inauspicious and untoward incident arising from the use of the dilapidated structure, the Sangguniang Barangay of Tandang Sora adopted Resolution No. 08, S-2000, authorizing the Punong Barangay to enter into any contract necessary in the expeditious implementation of its project to construct a two-storey building of Banlat Health Center on a portion of a parcel of land owned by the City government described under Transfer Certificate of Title Numbered RT-21706 (246722) at a cost of P2.5 Million to be taken from the barangay budget for the current year.
