WHEREAS, petitioner JETTI Corporation has requested the Quezon City Council for the issuance of a Special Use Permit for the construction of a filling station on the parcel of land at General Ave. along Tandang Sora Avenue, covered by TCT No. 120917 of the Registry of Deeds of Quezon City


WHEREAS, the construction/establishment of the filling station in the above stated area in Quezon City is beneficial to the general public and that the same conforms with the list of permitted uses which require the issuance of a Special Use Permit under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992", and its Implementing Rules and Regulations through an appropriate measure passed by the City Council authorizing the construction thereof;

WHEREAS, petitioner JETTI Corporation has guaranteed that it shall conform with the standards for filling stations set by the Department of Environment and Natural Resources and shall provide adequate safety measures and the necessary fire-fighting equipment in the vicinity.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to JETTI Corporation for the construction of a filling station on the parcel of land at General Avenue along Tandang Sora Avenue covered by TCT No. 120917 of the Registry of Deeds of Quezon City.
