RESOLUTION NO. ~~SP 429~~ S-2000

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE NINE (9) FAMILY-HOMEOWNERS WHO WERE VICTIMS OF THE FIRE THAT OCCURRED ON JANUARY 16, 2000 AT MAGANDA STREET, BARANGAY GULOD, NOVALICHES, QUEZON CITY, AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY-HOMEOWNER, OR IN THE TOTAL AMOUNT OF EIGHTEEN THOUSAND PESOS (P18,000.00) TO BE TAKEN FROM THE BUDGET FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS FOR THE YEAR 2000.

WHEREAS, a fire of undetermined origin occurred in the afternoon of January 16, 2000, at Maganda Street, Barangay Gulod, Novaliches, Quezon City, and rendered nine (9) families homeless, as per initial report of the Social Services and Development Department;

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991, explicitly provides, that:

"The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code, and shall:

(iv) Adopt measures to protect the inhabitants of the city from natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events".

WHEREAS, it is incumbent upon the City government to extend assistance in any form to the above-mentioned fire victims who are constituents of the city to cushion the impact of this unforeseen event.


