A RESOLUTION AMENDING RESOLUTION NO. SP-923, S-98, BY ACQUIRING THIRTY (30) SQUARE METERS OF THE LOT OWNED BY FILIPINA S. RAMOS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED N-207562, INSTEAD THAT OF GLORIA FRANCO REYES, FOR THE USE AS THE RIGHT-OF-WAY BY THE SANTOS COMPOUND NEIGHBORHOOD ASSOCIATION.

WHEREAS, the Quezon City Council during its regular session had adopted Quezon City Resolution No. SP-923, S-98, entitled: "A Resolution authorizing the Honorable Ismael A. Mathay, Jr., Mayor of Quezon City to enter into a contract of sale with Gloria Franco Reyes for the purchase of a strip of land measuring two (2) meters which is a portion of that parcel of land covered by Transfer Certificate of Title Numbered 15472 issued in her name, situated in Doña Rosario Subdivision, Barangay Novaliches Proper, Quezon City," by reason of the petition/request of Santos Compound Neighborhood Association;

WHEREAS, the said association after a long negotiation with the owner, Gloria Franco Reyes, failed to get favorable terms and conditions or agreement, thus prompting them to negotiate with the adjoining lot owner who is ready and willing to dispose a portion of her lot for the said right-of-way;

WHEREAS, the Quezon City government in its General Annual Budget had appropriated a certain amount for the acquisition of a portion of lot owned by Gloria Franco Reyes and not for the lot owned by Filipina S. Ramos, and thus, in order to serve its purpose, there is a need to amend Quezon City Resolution No. SP-923, S-98.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to amend, as it does hereby amend, Quezon City Resolution No. SP-923, S-98, by acquiring thirty (30) square meters of the lot owned by Filipina S. Ramos covered by Transfer Certificate of Title Numbered N-207562, instead that of Gloria Franco Reyes, for the use as the right-of-way by the Santos Compound Neighborhood Association.

RESOLVED, FURTHER, that the amount appropriated by the Quezon City government under its General Fund Budget, be applied for the purchase of the lot owned by Filipina S. Ramos.
