RESOLUTION NO. SP- 4 4 3 12 , 8-2000

A RESOLUTION AUTHORIZING THE ONE HUNDRED FORTY TWO (142) BARANGAYS OF QUEZON CITY TO USE THEIR SHARE OF UNPROGRAMMED APPROPRIATION FROM THE LOCAL GOVERNMENT SERVICE EQUALIZATION FUND (LGSEF), AMOUNTING TO THIRTY-SEVEN MILLION FIVE HUNDRED FIFTY-TWO THOUSAND PESOS (P37,552,000.00), CHARGED AGAINST THE INTERNAL REVENUE ALLOTMENT (IRA) FOR THE YEAR 2000.

WHEREAS, the Memorandum for the President dated June 28, 2000 issued by DBM Secretary Benjamin Diokno, has specified two (2) key points of consideration as bases for the approval and for its consequential release, that there is an available fund representing share of the local government units for year 2000 out of the Unprogrammed Fund (UF) for Internal Revenue Allotment, amounting to P10 Billion, of which P2.5 Billion has already been released representing the 1st quarter requirement and in lien of releasing the P2.5 Billion chargeable against the Unprogrammed fund which is premised on the realization of the original revenue target for the 2nd quarter and considering that the said target may not be met, it was recommended instead, the release of the said amount chargeable against the LGSEF to be distributed to various LGUs applying the codal formula of the IRA, a copy of the Memorandum is attached and made as an integral part hereof;

WHEREAS, the total amount due to Quezon City out of the unprogrammed appropriation from the LGSEF is Thirty-Seven Million Five Hundred Fifty-Two Thousand Pesos (P37,552,000.00) for year 2000 based on the first quarter release which is Nine Million Three-Hundred Eighty-Eight Thousand Pesos (P9,388,000.00) earmarked for the Peace and Order Program, in line with the priority Socio-Economic and Development Agenda of the Estrada Administration;

WHEREAS, the codal formula adopted by the DBM for the release, only 140 barangays of this City were the recipients, and the share for the 3 barangays (Greater Lagro, North Fairview and Pasong Putik Proper) which was the result of the splitting of Barangay Pasong Putik (through a plebiscite on December 1996 pursuant to Ordinance No. SP-439, S-96) was credited in favor of Barangay Pasong Putik Proper to be divided equally;

WHEREAS, in order for the concerned barangays of Quezon City to use the said funds, there is a need to adopt a resolution to clear the way for its release subject to proper accounting and auditing procedures of the city government;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the One Hundred Forty-Two (142) barangays of Quezon City to use their share of unprogrammed appropriation from the Local Government Service Equalization Fund (LGSEF) amounting to Thirty-Seven Million Five Hundred Fifty-Two Thousand Pesos (P37.552,000.00), charged against the Internal Revenue Allotment (IRA) for the year 2000.

RESOLVED, FURTHER, that a copy of this Resolution be forwarded to the One Hundred Forty Two (142) barangays, the Barangay Operations Center, City Budget Office, the City Treasurer's Office, the City Accounting Department, and all concerned offices of Quezon City.
