TO PROVIDE HEALTH CARE BENEFITS, THRU THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), TO ALL BARANGAY COUNCIL COMPOSED OF BARANGAY CAPTAINS, BARANGAY KAGAWADS, BARANGAY SECRETARIES AND BARANGAY TREASURERS AND ALLOCATING THE NECESSARY AMOUNT IN THE YEAR 2001 BUDGET AND EVERY YEAR THEREAFIER.

WHEREAS, some of our Barangay Council members belong to the low income group and thus can not avail of proper medical attention, care and hospitalization when the need arises;

WHEREAS, the Barangay Council members perform a very important role in delivering basic and vital services in their respective communities;

WHEREAS, the Philippine Health Insurance Corporation (Philhealth), a government-owned and controlled corporation has offered a premium contribution scheme which is reasonable and affordable for employers and employees in the private and public sectors, as well as other individuals willing to avail on a voluntary basis;

WHEREAS, thru Philhealth, the Quezon City government can assure the members of the Barangay Council that in the event of illness they will receive proper medical attention and care.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, urge, as it does hereby urge, the Honorable City Mayor Ismael A. Mathay, Jr. to provide health care benefits thru the Philippine Health Insurance Corporation (Phil-health), to all Barangay Council composed of Barangay Captains, Barangay Kagawads, Barangay Secretaries and Barangay Treasurers and allocating the necessary amount in the year 2001 budget and every year thereafter.
