RESOLUTION NO. SP: 1447, S-2000

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO FLYING V FOR THE CONSTRUCTION OF A GASOLINE SERVICE STATION ON THE PARCEL OF LAND ALONG MINDANAO AVENUE, BARANGAY TALIPAPA, COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED N-192818 AND N-192819 OF THE REGISTRY OF DEEDS OF QUEZON CITY.

WHEREAS, petitioner Flying V has requested the City Council for the issuance of a Special Use Permit for the construction of a gasoline service station on the parcel of land along Mindanao Avenue, Barangay Talipapa, covered by Transfer Certificates of Title Numbered N-192818 and N-192819 of the Registry of Deeds of Quezon City;

WHEREAS, the construction of the gasoline service station in the above-stated area in Quezon City is beneficial to the general public and that the same conforms with the list of permitted uses which require the issuance of a Special Use Permit under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992", and its Implementing Rules and Regulations through an appropriate measure passed by the City Council authorizing the construction thereof;


WHEREAS, petitioner Flying V has guaranteed that it shall conform with the standards for gasoline service stations set by the Department of Environment and Natural Resources and provide adequate safety measures and the necessary fire-fighting equipment in the vicinity;


NOW, THEREFORE,
