RESOLUTION NO. SP-1449 S-2000

A RESOLUTION RATIFYING THE DEED OF DONATION ENTERED INTO BY AND BETWEEN THE IGLESIA NI CRISTO, THRU EXECUTIVE MINISTER ERAÑO G. MANALO, AS DONOR, AND THE QUEZON CITY GOVERNMENT, THRU THE CITY MAYOR, THE HONORABLE ISMAEL A. MATHAY, JR., AS DONEE, INVOLVING TWO PARCELS OF LAND TOGETHER WITH ALL THE IMPROVEMENTS THEREON, CONTAINING A TOTAL AREA OF TWO HUNDRED FORTY-SIX (246) SQUARE METERS, MORE OR LESS, AND MORE PARTICULARLY DESCRIBED UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED 43353 OF THE REGISTRY OF DEEDS OF QUEZON CITY.

WHEREAS, under the Deed of Donation entered into by and between the IGLESIA NI CRISTO, thru its Executive Minister Eraño G. Manalo, and the Quezon City government, thru the Honorable Ismael A. Mathay, Jr., City Mayor of Quezon City, the former donated to the latter parcels of land together with all existing improvements thereon containing an area of Two Hundred Forty-Six (246) square meters, more or less;

WHEREAS, the parcels of land donated are portions of the Housing Project funded/sponsored by the Iglesia Ni Cristo for the benefit of the members of the Iglesia Ni Cristo who are members of the Nagkakaisang Diwa Neighborhood Association located at Barangay Ugong Norte, Quezon City;


WHEREAS, the ratification of said donation by the City Council of Quezon City will promote public welfare and serve the best interest of the residents;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Deed of Donation entered into by and between the Iglesia Ni Cristo, thru Executive Minister Eraño G. Manalo, as Donor, and the Quezon City government, thru the City Mayor, the Honorable Ismael A. Mathay, Jr., as Donee, involving two parcels of land together with all the improvements thereon containing a total area of Two Hundred Forty-Six (246) square meters, more or less, more particularly described under Transfer Certificate of Title Numbered 43353 of the Registry of Deeds of Quezon City.
