RESOLUTION NO. SP- 1454, S-2000

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PAREE-NORTHFIELD SCHOOL FOR BOYS, INC., A NON-STOCK, NON-PROFIT CORPORATION DULY ORGANIZED UNDER PHILIPPINE LAWS, FOR THE DEVELOPMENT OF A PARCEL OF LAND OWNED BY THE QUEZON CITY GOVERNMENT, COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 284328, CONSISTING OF THIRTY ONE THOUSAND SIX HUNDRED EIGHTY-NINE (31,689) SQUARE METERS, MORE OR LESS, INTO A PARK WITH SCHOOL PARTICULARLY THE NORTHFIELD SCHOOL FOR BOYS.

WHEREAS, the Quezon City government is the owner of a parcel of land identified as Lot 14, Block 13, consisting of Thirty One Thousand Six Hundred Eighty-Nine (31,689) square meters, more or less, covered by Transfer Certificate of Title Numbered 284328 and located at Greenmeadows Subdivision, Phase III, Quezon City;

WHEREAS, the Paree Northfield School for Boys, Inc., a non-stock, non-profit corporation duly organized and existing under Philippine laws, with principal office located at 107 Scout Gandia, Kamuning, Quezon City, has proposed to the Quezon City government thru the Honorable City Mayor to develop the above described real property of the City government into a Park with a School;

WHEREAS, the Third Greenmeadows Homeowners Association where the above mentioned real property of Quezon City is located, has manifested their conformity with the proposal of Paree Northfield School for Boys, Inc.;


WHEREAS, the Ortigas Company Limited Partnership, the entity that donated the subject parcel of land to Quezon City signified that as Donor of the property they do not interpose any objection to the proposal of Paree Northfield School for Boys, Inc., as in fact they strongly endorsed the proposed project as "a very worthy private sector-local government undertaking."

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mabay Jr., City Mayor, to enter into a Memorandum of Agreement with the Paef-Northfield School for Boys, Inc., a non stock, non profit corporation duly organized under Philippine laws, for the development of a parcel of land owned by the Quezon City government, covered by Transfer Certificate of Title Numbered 284328, consisting of Thirty One Thousand Six Hundred Eighty Nine (31,689) square meters, more or less, into a Park with a School particularly the Northfield School for Boys.
