RESOLUTION NO. SP-1458, S-2000

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO ACCEPT THE DONATION BEING MADE BY FORMER SENATOR MAGNOLIA W. ANTONINO IN FAVOR OF THE QUEZON CITY GOVERNMENT INVOLVING A PARCEL OF LAND LOCATED AT BARANGAY PAYATAS B, QUEZON CITY, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. RT-5567 (35493) COVERING AN AREA OF TWO THOUSAND AND THIRTY (2,030) SQUARE METERS.
