RESOLUTION NO. SP-1459, S-2000

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE ISMAEL A. MATHAY, JR., TO GRANT TEMPORARY PERMIT TO THE SAMAHAN NG MGA VENDORS SA NORTH AVENUE MRT-III TO VEND ALONG EDSA FRONTING THE MRT WALL, MRT NORTH AVENUE STATION.

WHEREAS, the Samahan ng mga Vendors sa North Avenue MRT-III (SVNE-MRT III for brevity), is a duly organized vendors association composed of eighty (80) members;

WHEREAS, this SVNE-MRT III are all actual residents of Agham Road, Barangay Bagong Pag-asa, and were dislocated during the past administration by reason of the construction of the People's Park along North Avenue in front of SM City;

WHEREAS, they are presently vending along EDSA near the MRT III North Avenue Station together with other vendors who are non-residents of the barangay;

WHEREAS, to provide them livelihood especially this coming Christmas season and to make orderly vending arrangement, the City should grant them authority/permit to vend as they have already sought the approval of the City Mayor and the City government through Mr. Teodoro Rey who has already proposed a vending site for them;

WHEREAS, it is incumbent upon the City Council as provided in Section 458 par. (5) sub-par. (ii) of the Local Government Code of 1991, which reads:

"Establish markets, slaughterhouses or animal corrals and authorize the operation thereof by the City government, and regulate the construction of private markets, talipapas or other similar buildings and structures."

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ismael A. Mathay, Jr., to grant temporary permit to the Samahan ng mga Vendors sa North Avenue MRT-III to vend along EDSA fronting the MRT wall, MRT North Avenue Station; PROVIDED, that vendors shall maintain the cleanliness of the area and shall not obstruct the free flow of traffic.

RESOLVED, FURTHER, that a copy of this resolution be immediately forwarded to the Office of the Honorable City Mayor for his appropriate action.
