RESOLUTION NO. SP- 1464 ,S-2000

A RESOLUTION URGING THE EXECUTIVE JUDGES OF THE REGIONAL TRIAL COURT AND METROPOLITAN TRIAL COURT OF QUEZON CITY TO REQUIRE THE EX-OFFICIO SHERIFF TO FURNISH THE CITY COUNCIL AND THE BARANGAY COUNCIL CONCERNED OF DEMOLITION OR EJECTMENT ORDERS ISSUED BY THE COURTS BEFORE THE EXECUTION/IMPLEMENTATION THEREOF.

WHEREAS, the Sangguniang Panlungsod shall approve resolutions for the general welfare of the City and its inhabitants pursuant to Section 16 of the Local Government Code;

WHEREAS, more often than not, demolition or ejectment orders issued by the Courts are implemented/executed in Quezon City, leaving behind the affected parties in a sad plight;

WHEREAS, the City government may give assistance to the affected parties should be notified and aware of the intended demolition or ejectment;

WHEREAS, in order to give ample time to the City government and the Barangay Council concerned in extending assistance to the affected parties the former should at least be furnished a copy of the demolition or ejectment order;

NOW, THEREFORE,


BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Executive Judges of the Regional Trial Court and Metropolitan Trial Court of Quezon City to require the Ex-Officio Sheriff to furnish the City Council and the Barangay Council concerned of demolition or ejectment orders issued by the Courts before the execution/implementation thereof.
