RESOLUTION NO. SP- 1466 -S-2000

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., TO GRANT TEMPORARY PERMIT TO THE NORTH EDSA VENDORS ASSOCIATION TO VEND ALONG NORTH AVENUE FRONTING SM CITY MRT WALL, MRT NORTH AVENUE STATION.

WHEREAS, the Samahan ng mga Vendors sa North Edsa Vendors Association Inc., NEVA for brevity, is a duly organized vendors' association composed of 128 members;

WHEREAS, the members of NEVA, Inc. are all actual residents of San Roque II Barangay Bagong Pag-asa and were dislocated during the past administration by reason of the construction of the People's Park along North Avenue in front of SM City;

WHEREAS, they are presently vending along EDSA near the MRT III North Avenue Station together with other vendors who are non-residents of the barangay;

WHEREAS, to provide them livelihood especially this coming Christmas season and to make orderly vending arrangement, the city should grant them authority/permit to vend as they have already sought the approval of the City Mayor and the City Government through Mr. Teodoro Rey who already proposed a vending site for them;

WHEREAS, it is incumbent upon the city council as provided in Section 458 par. (5) sub par (ii) of the Local Government Code of 1991, which reads:

"Establish markets, slaughterhouses or animal corrals and authorize the operation thereof by the city government and regulate the construction of private markets, talipapas or other similar buildings and structures."
