## RESOLUTION NO. SP-1468, S-2000

A RESOLUTION STRONGLY URGING EVERY COMPONENT BARANGAY OF QUEZON CITY TO SET ASIDE AND APPROPRIATE THE SUM OF ONE THOUSAND TWO HUNDRED PESOS (P1,200.00) EVERY YEAR IN ITS ANNUAL BUDGET AS CONTRIBUTION TO THE ASSOCIATION OF BARANGAY TREASURERS, QUEZON CITY, INC.

WHEREAS, the Barangay Treasurers of the 142 component Barangays of Quezon City have organized themselves into an association in order to assist the Barangays in undertaking proper, efficient and effective financial management.

WHEREAS, the mission statement, objectives and goal of the Association of Barangay Treasurers—Quezon City, Inc., are consistent with those of the Barangays they profess to serve, and their continued existence and operation will augur well to the best interests of the Barangays and their constituents.

WHEREAS, on August 30, 2000, the Association of Barangay Treasurers — Quezon City, Inc. passed and adopted during its General Assembly Resolution No. ABT-03, S-2000, requesting that every component Barangay in Quezon City contribute the sum of One Thousand Two Hundred Pesos (P1,200.00) annually for operational expenses of the association, to be appropriated and set aside in the annual budgets of the One Hundred Forty Two component barangays.

WHEREAS, it is the strong sentiment of the Quezon City Council that such annual linancial contribution of One Thousand Two Hundred Pesos (P1,200.00) by every component Barangay in Quezon City to the Association of Barangay Treasurers – Quezon City, Inc., is for the best interest of public service.
