A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO PETITIONER EVERGREEN FOOD CORPORATION FOR THE CONSTRUCTION OF A TWO-STOREY WAREHOUSE BUILDING LOCATED AT QUEZON CITY IN ACCORDANCE WITH THE PROVISIONS OF THE "QUEZON CITY ZONING ORDINANCE OF 1992."

WHEREAS, petitioner Evergreen Food Corporation represented by its President, Mr. Mannel A. Go, has requested for the issuance of a Certificate of Exception for the construction of a two-storey warehouse building at Lot 1, Carolin Park Subdivision, Quezon City covered by TCT No. N-203478;

WHEREAS, the said project which is a permitted use in a Commercial Zone is located in an area presently classified as Medium Density Residential (R-2) Zone;

WHEREAS, exceptions, variances and or deviations from the provisions of the Implementing Rules and Regulations of the Zoning Ordinance, specially Article 3 B of Rule VII, may be allowed upon authorization by the City Council thru a resolution and compliance with the terms and conditions stipulated therein.
