RESOLUTION NO. SP-T 484, S-2000

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY HIS HONOR, MAYOR ISMAEL A. MATHAY, JR., AND AMARANTH TRADING AND DEVELOPMENT CORPORATION, REPRESENTED BY ITS MANAGER, MR. EDILBERTO H. VILLANUEVA, FOR THE PROPOSED REPAIR AND IMPROVEMENT OF BARANGAY OPERATIONS CENTER OFFICE (PHASE III) LOCATED AT QUEZON CITY HALL COMPOUND, SUBJECT TO EXISTING ACCOUNTING AND AUDITING RULES AND REGULATIONS

WHEREAS, the Quezon City government represented by His Honor, Mayor Ismael A. Mathay, Jr., had entered into a negotiated contract, with Amaranth Trading and Development Corporation for the proposed repair and improvement of Barangay Operations Center (Phase III) located at Quezon City Hall Compound, copy thereof is hereto attached as Annex A hereof;

WHEREAS, there is a need to implement immediately the said repair and improvement to avoid possible loss of life and property due to the deteriorating condition of the building and to afford its employees and the general public transacting business with Barangay Operation Center with decent and convenient place to work and transact official business.

WHEREAS, Section 22 of Republic Act No. 7160, provides that unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;


WHEREAS, a resolution was passed and adopted by the City Council granting authorization to the City Mayor to enter into contract in compliance with the provision of Local Government Code of 1991.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the contract entered into by and between the Quezon City government, represented by His Honor, Mayor Ismael A. Mathay, Jr., and Amaranth Trading and Development Corporation, represented by its Manager, Mr. Edilberto H. Villanueva, for the proposed repair and improvement of Barangay Operations Center Office (Phase III) located at Quezon City Hall Compound, subject to existing accounting and auditing rules and regulations.

RESOLVED FURTHER, that copy of this Resolution be forwarded to the Office of the City Mayor and to concerned offices, for information and appropriate action.
