A RESOLUTION AUTHORIZING HIS HONOR, CITY MAYOR ISMAEL A. MATHAY, JR., TO ENTER INTO A NEGOTIATED CONTRACT FOR THE INSTALLATION OF DRAINAGE AT L. CASTILLO AND DATA STREETS, BARANGAY DON MANUEL, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED SEVENTY-THREE THOUSAND SEVEN HUNDRED FORTY-ONE AND NINETY-FIVE CENTAVOS (P273, 741.95).

WHEREAS, the Hon. Milagros G. Reyes, Punong Barangay of Barangay Don Manuel, Quezon City, has requested for the installation of drainage at L. Castillo and Data Streets, areas that are historically prone to flash floods;

WHEREAS, after thorough inspection and investigation by the City Engineer's Office, it was revealed that some of the existing reinforced concrete pipes, particularly at L. Castillo St., have been to be heavily silted and clogged;

WHEREAS, the installation of 24"Ø reinforced concrete pipe at a portion of L. Castillo Street will prevent flooding along the said street and the construction of curb & gutter will prevent surface water run-off from going to the house of the residents;

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code, provides that, "The City Mayor, as chief executive of the city government, shall exercise powers and perform duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants,
