RESOLUTION NO SP-1400 , S-2000

A RESOLUTION URGING ALL THE MUNICIPALITIES AND CITIES ALL OVER THE PHILIPPINES TO PROVIDE HEALTH CARE BENEFITS THROUGH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH), A GOVERNMENT-OWNED AND CONTROLLED CORPORATION, TO ALL THEIR BARANGAY OFFICIALS, SANGGUNIANG KABATAAN (SK) OFFICIALS, LUPON TAGAPAMAYAPA MEMBERS, AND REGULAR BARANGAY SECURITY AND DEVELOPMENT OFFICERS (BSDOS).

WHEREAS, the high cost of medicines and hospitalization have become prohibitive such that not all of the barangay officials can avail thereof;

WHEREAS, some of these barangay officials, Sangguniang Kabataan officials, Lupon Tagapamayapa members and regular Barangay Security and Development Officers belong to the poor and marginalized sector of our society and, thus, cannot afford the best medical care when needed:

WHEREAS, the Philippine Health Insurance Corporation (Philhealth), a government-owned and controlled corporation, has offered a premium contribution scheme which is reasonable and affordable;

WHEREAS, through Philhealth, the cities and municipalities all over the Philippines can assure their Barangay officials, SK officials, Lupon members and BSDOs that in the event of illnesses they can avail of proper medical care, attention and hospitalization.
