RESOLUTION NO. SP-1-192 S-2000

A RESOLUTION URGING THE QUEZON CITY GOVERNMENT TO ADOPT THE PUBLIC HOUSING CONCEPT TO ADDRESS THE HOUSING NEEDS OF QUEZON CITY RESIDENTS WHO CURRENTLY CANNOT AFFORD THE PRESENT MARKET RATES OF SOCIALIZED HOUSING PROGRAM BEING UNDERTAKEN BY THE CITY AND OTHER PUBLIC AND PRIVATE ENTITIES AND TO REQUEST FROM THE HOUSING AND URBAN DEVELOPMENT COORDINATING COUNCIL THE NECESSARY FUNDS FOR ITS IMPLEMENTATION

WHEREAS, shelter is one of the basic needs of the people;

WHEREAS, despite exhausting all means to address this pressing problem of providing proper shelter to Quezon City residents, there are still others who are not benefiting from the effort;

WHEREAS, occurrence of tragedies such as at Payatas will continue to threaten Quezon City residents along areas not intended for residential use;

WHEREAS, public housing will answer the need for shelter to Quezon City residents who belong to the urban poor and cannot afford the equity and monthly amortization of socialized housing;

WHEREAS, the public houses shall be located within Quezon City so that beneficiaries will still be near their respective workplace;

WHEREAS, public houses shall be leased to beneficiaries for reasonable monthly rates and shall be considered as their transient home until such time that they are ready and able to transfer to socialized housing;

WHEREAS, at present, the Quezon City government cannot implement the Public Housing Concept due to budgetary constraints;

WHEREAS, the Housing and Urban Development Coordinating Council, being a national agency, can allocate the necessary funds for the implementation of this concept.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Quezon City government to adopt the Public Housing Concept to address the housing needs of Quezon City residents who currently cannot afford the present market rates of socialized housing program being undertaken by the city and other public and private entities and to request from the Housing and Urban Development Coordinating Council the necessary funds for its implementation.
