RESOLUTION NO. SP-1493, S-2000

A RESOLUTION EXTENDING HEARTFELT CONGRATULATIONS AND DUE RECOGNITION TO MR. ALBERTO C. SAMSON, LOCAL TREASURY OPERATION OFFICER II UNDER THE OFFICE OF THE CITY TREASURER, QUEZON CITY, FOR HIS REMARKABLE AND EXCELLENT PERFORMANCE IN THE COLLECTION OF BUSINESS TAXES.

WHEREAS, taxes are the lifeblood of the government without which, vital State functions would be paralyzed;

WHEREAS, heeding to the call of His Honor, Mayor Ismael A. Mathay, Jr., to improve efficiency in the collection of taxes, Mr. Alberto C. Samson, as Revenue Officer, outstandingly performed his tasks which prompted the New San Jose Builders, Inc. to settle its tax deficiency with the City government amounting to One Million Forty-Nine Thousand Four Hundred Ninety Pesos and Seventy-Five Centavos (P1,049,490.75);

WHEREAS, in a letter dated August 8, 2000 of Mr. Danilo F. Zamora, Local Treasury Operation Officer V, addressed to City Treasurer Alfredo M. Cortez it was revealed that prior to the One Million Forty-Nine Thousand Four Hundred Ninety Pesos and Seventy-Five Centavos (P1,049,490.75) tax collection of Mr. Samson the latter was able to collect Two Million Eight Hundred Forty-Nine Thousand Five Hundred Ninety-Three Pesos and Thirty-Five Centavos (P2,849,593.35), a copy of the said letter is attached and shall form part of this resolution;

WHEREAS, such accomplishment of Mr. Samson is a big contribution to the scarce resources of the city government, hence, more project and services to the city inhabitants;

WHEREAS, as a manifestation of support to an outstanding employee and as a morale booster, it is fair and fitting to extend heartfelt congratulations and due recognition for the job well done;
