RESOLUTION NO. SP-1498, S-2000

A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, AS THE FIRST PARTY AND GECYCON BUILDERS & CONSTRUCTION SUPPLY REPRESENTED BY MRS. CONCEPCION G. CABACABA, FOR THE PROPOSED DRAINAGE IMPROVEMENT OF BATTULAYAN STREET, BARANGAY PAYATAS A, QUEZON CITY, SUBJECT TO EXISTING ACCOUNTING AND AUDITING RULES AND REGULATIONS.

WHEREAS, the Quezon City Government had entered into a contract, represented by His Honor, Ismael A. Mathay, Jr., with Gecycon Builders and Construction, for the proposed drainage improvement of Battulayan Street, Barangay Payatas A, Quezon City, copy of which is hereby attached as Annex A;

WHEREAS, there is a need to implement immediately the said repair and improvement to avoid possible loss of life and property particularly during rainy season or occurrence of heavy rains and flashfloods;

WHEREAS, Section 22 of Republic Act No. 7160, provides that unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without authority from the sanggunian concerned.

Cabacaba, for the proposed drainage improvement of Battulayan Street, Barangay Payatas A, Quezon City.


