RESOLUTION NO. SP-1515, S:2001

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE PO3 FERDINAND P. SANCHEZ, A MEMBER OF THE CENTRAL POLICE DISTRICT COMMAND (CPDC), ASSIGNED AT STATION 4, QUEZON CITY, WHO DIED ON NOVEMBER 4, 1998, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS UNDER THE OFFICE OF THE CITY MAYOR IN THE ANNUAL BUDGET FOR FISCAL YEAR 2001.

Introduced by Councilors ERIC Z. MEDINA, GODOFREDO T. LIBAN II, MARCIANO P. MEDALLA, JORGE L. BANAL and JULIAN M.L. COSETENG.

WHEREAS, PO3 Ferdinand P. Sanchez served Quezon City with utmost dedication, commitment and loyalty for almost ten (10) years;

WHEREAS, due to his courage and fidelity in the service, he encountered criminal syndicates engaged in illegal drug trade and other anti-social activities in Quezon City;

WHEREAS, to stop PO3 Sanchez in going after criminals, in the evening of November 4, 1998, an unidentified assassin treacherously attacked him while inside his residence and then mercilessly shot to death;

WHEREAS, due to his untimely demise, his family suffered emotional stress, as well as financial losses being the lone provider;

WHEREAS, as a gesture of sympathy to the fate suffered by PO3 Sanchez and in recognition to his achievements as a dedicated policeman, it is but fitting for the city government to grant financial assistance to his bereaved family.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION DULY ASSEMBLED, to grant, as it does hereby grant, financial assistance to the bereaved family of the late PO3 Ferdinand P. Sanchez, a member of the Central Police District Command (CPDC), assigned at Station 4, Quezon City, who died on November 4, 1998, in the amount of Thirty Thousand Pesos (P30,000.00), to be taken from the appropriations for grants, subsidies and contributions under the Office of the City Mayor in the Annual Budget for Fiscal Year 2001.
