A RESOLUTION URGING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, THIS CITY, TO EXEMPT FROM THE PAYMENT OF AMUSEMENT TAX THE ZSA ZSA PADILLA, FREESTYLE AND LANI MISALUCHA CONCERT TO BE HELD AT THE ARANETA COLISEUM ON FEBRUARY 14, 2001 SPONSORED BY VIVA ENTERTAINMENT GROUP.

WHEREAS, all proceeds of the concert will be used as a base to build a foundation for artist in the Music Entertainment World who are either disabled or whose talent had been impaired by accident, disease or other causes and also those who can no longer use their talent to earn a living;

WHEREAS, considering that all proceeds will go to a charitable cause with no gain to be realized by the Sponsor VIVA Entertainment Group, the exemption from the payment of amusement taxes can be considered as a just return for the tireless effort of the ORGANIZERS and artists/performers.

## NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable Ismael A. Mathay, Jr., City Mayor, this city, to exempt from the payment of amusement tax the Zsa Zsa Padilla, Freestyle and Lani Misalucha Concert to be held at the Araneta Coliseum on February 14, 2001 sponsored by VIVA Entertainment Group.
