A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ISMAEL A. MATHAY, JR., TO ENTER INTO NEGOTIATED CONTRACT OF REPAIR AND RENOVATION PROJECT OF THE THIRD FLOOR PARTICULARLY THE ADMINISTRATIVE DIVISION OF THE CITY TREASURER'S OFFICE IN ACCORDANCE WITH THE ATTACHED PHOTOCOPY OF THE PROGRAM OF WORK, AND AT SUCH AMOUNT NOT EXCEEDING ITS COST ESTIMATE TO BE CHARGED AGAINST THE REPAIR AND MAINTENANCE OF GOVERNMENT FACILITIES FUND FOR FY 2000.

WHEREAS, pursuant to Section 455 (b) (1) (vi) of R.A. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall, "(vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sanggumang Panlungson or pursuant to law or ordinance";
