RESOLUTION NO. SP. 1527

A RESOLUTION URGING ALL QUEZON CITY GOVERNMENT OFFICIALS AND EMPLOYEES TO COMPLY WITH THE PROVISIONS OF REPUBLIC ACT NO. 6713, OTHERWISE KNOWN AS THE CODE OF CONDUCT AND ETHICAL STANDARDS FOR PUBLIC OFFICIALS AND EMPLOYEES, PARTICULARLY ON THE REQUIREMENT OF ACTING PROMPTLY ON THE PUBLIC'S PERSONAL TRANSACTIONS AND COMMUNICATIONS.

WHEREAS, Sec. 5, paragraph (a) of Republic Act No. 6713, otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, states that "All public officials and employees shall within fifteen (15) working days from receipt thereof, respond to letters, telegrams, or other means of communication sent by the public. The reply must contain the action taken on the request?;

WHEREAS, despite the passage of Republic Act No. 6713, public officials and employees in Quezon City, have in countless situations and circumstances failed to comply with the provisions of the said law in relation to their duties to act promptly on letters and requests by the public;

WHEREAS, the failure of Quezon City government officials and employees to respond within the fifteen-day period provided by the said law has caused irreparable harm and injury to the interest of the public;

WHEREAS, it is extremely necessary to correct this practice in order to fully afford to the public the service that they rightfully deserve.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to arge, as it does hereby arge, all Quezon City government officials and employees to comply with the provisions of Republic Act No. 6713, otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, particularly on the requirement of acting promptly on the public's personal transactions and communications.
