RESOLUTION NO. SP- 1528, S-2001

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO THE HONORABLE ANTONIO L. SIOSON, WHO IS ON HIS THIRD TERM AS CITY COUNCILOR OF QUEZON CITY, THE ASSIGNED MOTOR VEHICLE PARTICULARLY IDENTIFIED AS TOYOTA TAMARAW FX WITH PLATE NO. SEK 573 WHICH HE IS OFFICIALLY USING DURING HIS INCUMBENCY AS CITY COUNCILOR AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, all City Councilors have been issued motor vehicles by the Quezon City government for their official use in connection with the exercise of their official functions;

WHEREAS, the Honorable Antonio L. Sioson, who is on his third term as Councilor, has been serving his constituents for the past eight (8) years;

WHEREAS, the motor vehicle assigned to Councilor Sioson is hereby described, as follows:

WHEREAS, the sale of the assigned motor vehicle to Councilor Sioson would be beneficial and advantageous to the Quezon City government as it would be a means to recover the funds used in purchasing the vehicle, instead of putting up additional funds for the acquisition thereof;


WHEREAS, Section 16 of the Local Government Code of 1991 authorizes the Quezon City Council to enact reasonable and wholesome measures that would promote the welfare of the inhabitants of the city.
