RESOLUTION NO. SP-1531, S-2001

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE SEVEN HUNDRED FIFTY-THREE (753) FAMILIES WHO WERE VICTIMS OF THE FIRE THAT OCCURRED ON SEPTEMBER 29, 2000 AT SITIO PAJO, BARANGAY BAESA, QUEZON CITY, COMPRISING OF THREE HUNDRED FORTY (340) FAMILY-HOMEOWNERS AT TWO THOUSAND PESOS (P2,000.00) EACH AMOUNTING TO SIX HUNDRED EIGHTY THOUSAND PESOS (P680,000.00) AND FOUR HUNDRED THIRTEEN (413) FAMILY-RENTERS/SHARERS AT ONE THOUSAND PESOS (P1,000.00) EACH AMOUNTING TO FOUR HUNDRED THIRTEEN THOUSAND PESOS (P413,000.00) OR IN THE TOTAL AMOUNT OF ONE MILLION NINETY-THREE THOUSAND PESOS (P1,093,000.00) TO BE TAKEN FROM THE BUDGET UNDER GRANTS, SUBSIDIES AND CONTRIBUTIONS FOR FY 2001.

WHEREAS, a fire occurred on September 29, 2000 at Sitio Pajo, Barangay Baesa, Quezon City, rendering seven hundred fifty-three (753) families homeless, three hundred forty (340) family-homeowners and four hundred thirteen (413) are family-renters/sharers, based on the report of the Social Services and Development Department;

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991, explicitly provides, that:

Sec. 458. (a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate power of the city as provided for under Section 22 of this Code, and shall:

(1) (iv) adopt measures to protect the inhabitants of the city from natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, it is incumbent upon the City government to extend assistance in any form to the above-mentioned fire victims who are constituents of the city to cushion the impact of this unforeseen event;



NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the seven hundred fifty-three (753) families who were victims of the fire that occurred on September 29, 2000 at Sitio Pajo, Barangay Baesa, Quezon City, comprising of Three Hundred Forty (340) family-homeowners at Two Thousand Pesos (P2,000.00) each amounting to Six Hundred Eighty Thousand Pesos (P680,000.00) and Four Hundred Thirteen (413) family-renters/sharers at One Thousand Pesos (P1,000.00) each amounting to Four Hundred Thirteen Thousand Pesos (P413,000.00) or in the total amount of One Million Ninety-Three Thousand Pesos (P1,093,000.00) to be taken from the Budget for Grants, Subsidies and Contributions for FY 2001.
