RESOLUTION NO. SP-1 5 3 22, 5-2001

A RESOLUTION AUTHORIZING QUEZON CITY GENERAL HOSPITAL TO USE TWELVE MILLION PESOS (P12 MILLION) FROM THE QUEZON CITY GENERAL HOSPITAL DEVELOPMENT FUND TO PURCHASE HOSPITAL EQUIPMENT, SUCH AS HEAVY DUTY MULTIPROBE ULTRASOUND MACHINE, PEDIATRIC VENTILATOR, ADULT VOLUME RESPIRATOR, CARDIAC MONITORS, DEFIBRILLATOR, CRYOSTAT MACHINE, PLASMA FREEZER AND OTHER EQUIPMENT URGENTLY NEEDED BY QUALITY HEALTH CARE SERVICES TO PATIENTS, **SUBJECT** GOVERNMENT AUDITING AND ACCOUNTING RULES REGULATIONS.

WHEREAS, the Quezon City General Hospital (QCGH) is a 250-bed tertiary general local government hospital where very serious illnesses remained undetected and untreated among the needy families in Quezon City due to lack of diagnostic, assistive and monitoring equipment, such as the ultrasound machine, defibrillator, pediatric ventilators, adult volume respirator, plasma freezer, cryostat machine, cardiac monitors and other equipment;

WHEREAS, the Bureau of Licensing and Regulation of the Department of Health has required all these equipment be made available to ensure safety among our patients as one of the requirements to obtain a renewal of QCGH's License to Operate as a tertiary level hospital;

WHEREAS, the Philippine Health Insurance Corporation has required that all the above equipment be made available to ensure quality of health care services being delivered to patients as one of the requirements to obtain a renewal of QCGH's accreditation as a health service provider in the National Health Insurance Program;

WHEREAS, the QCGH Quality Assurance Program has identified that the lack of these equipment are the major factors for the delay in the delivery of quality and appropriate health care services in the hospital;

WHEREAS, the accountant of the QCGH has certified that the amount of Twelve Million Pesos (12,000,000.00) is available in the Hospital Development Fund for the purchase of these badly needed equipment;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City General Hospital to use Twelve Million Pesos (12,000,000.00) from the Hospital Development Fund for the purchase of one heavy duty multiprobe ultrasound machine, pediatric ventilator, adult volume respirator, cardiac monitor, cryostat machine, defibrillator, plasma freezer and other equipment, urgently needed by the Quezon City General Hospital in order to provide quality health care services to patients, subject to government auditing and accounting rules and regulations.
