# RESOLUTION NO. 3P- 1534, S-2001

A RESOLUTION AUTHORIZING HIS HONOR, MAYOR ISMAEL A. MATHAY, JR., TO ENTER INTO A CONTRACT WITH DOWAL REALTY AND MANAGEMENT SYSTEMS, CO. (DREAMS), FOR THE PURCHASE OF ITS PROPERTY REGISTERED UNDER TRANSFER CERTIFICATE OF TITLE NUMBERED N-55202 WITH AN AREA OF FIVE THOUSAND SIX HUNDRED SEVEN (5,607) SQUARE METERS AND TRANSFER CERTIFICATE OF TITLE NUMBERED 55203 WITH AN AREA OF NINE THOUSAND THREE HUNDRED NINETY THREE (9,393) SQUARE METERS, BOTH LOCATED IN PAYATAS, QUEZON CITY, THE PRICE THEREOF SHALL BE DETERMINED BY THE CITY APPRAISAL COMMITTEE.

WHEREAS, the recent tragedy at the Payatas Dumpsite, as well as the impending closure of the San Mateo Landfill, has spawned the grave garbage crisis not only in Quezon City, but in the entire Metro Manila area;

WHEREAS, as a temporary solution to the said crisis, there is a need to develop a new dumpsite for the city's garbage/solid wastes;

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Mayor Ismael A. Mathay, Jr., to enter into a contract with Dowal Realty and Management Systems, Co. (DREAMS), for the purchase of its property registered under Transfer Certificate of Title Numbered N-55202 with an area
