MATHAY, JR., CITY MAYOR, QUEZON CITY, AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE REPRESENTED BY ITS GENERAL MANAGER, MS. ANGELITA K. BARRIENTOS FOR VARIOUS REPAIR OF HEALTH CENTERS UNDER THE SOLE RESPONSIBILITY OF THE QUEZON CITY GOVERNMENT.

WHEREAS, there is a need to implement immediately the said repair and improvement to avoid possible loss of life and property;

WHEREAS, Section 22 of Republic Act No. 7160, provides that unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the contract entered into by and between the Quezon City government, represented by His Honor, Ismael A. Mathay, Jr., City Mayor, Quezon City, with Angelot Construction & General Merchandise, represented by its General Manager, Ms. Angelita K. Barrientos, for various repair of Health Centers in Quezon City under the sole responsibility of Quezon City government.
