RESOLUTION NO. SP- 1548, S-2001

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FIRE VICTIMS CONSISTING OF SEVERAL FAMILIES WHOSE HOUSES WERE BURNED DOWN ON MARCH 16, 2001 AT POOK RICARTE, BARANGAY U.P. CAMPUS, QUEZON CITY, AT THE SUM OF TWO THOUSAND PESOS (P2,000.00) FOR EACH HOUSE OWNER AND ONE THOUSAND PESOS (P1,000.00) FOR EACH HOUSE RENTER/SHARER, WHICH WILL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR.

WHEREAS, on March 16, 2001, Pook Ricarte, Barangay U.P. Campus, District IV, Quezon City, was hit by fire rendering homeless, as per census by the Social Services Development Department (SSDD), one hundred eighteen (118) families, categorized as follows:

WHEREAS, because of this unfortunate incident the constituents, who are presently in makeshift dwellings, can only hope and pray for the early release of financial assistance from the City government;

WHEREAS, these unfortunate fire victims need the assistance of the City government in the form of financial aid to defray the cost of building materials for the reconstruction of their houses, purchase of foods, clothings and other necessary expenses in the amount of Two Thousand Pesos (P2,000.00) for each house owner and One Thousand Pesos (P1,000.00) for each house renter/sharer;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to extend, as it does hereby extend, financial assistance to the fire victims consisting of several families whose houses were burned down on March 16, 2001 at Pook Ricarte, Barangay U.P. Campus, Quezon City, at the sum of Two Thousand Pesos (P2,000) for each house owner and One Thousand Pesos (P1,000.00) for each house renter/sharer, which will be taken from the Calamity or Emergency Fund of the Honorable City Mayor Ismael A. Mathay, Jr.

RESOLVED, FURTHER, that the Social Services Development Department shall submit a report stating the exact number of families affected which shall serve as the basis for the allocation and release of the funds to the concerned agency to provide the necessary financial assistance to all identified fire victims, which shall be taken from the Calamity or Emergency Fund of the City government.

RESOLVED, FINALLY, that the Office of the City Engineer and the Office of the Social Services Development Department are hereby enjoined to coordinate as facilitators in the orderly implementation hereof.
