RESOLUTION NO. SP- 1552, S-2001

A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT ENTERED INTO BY THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., WITH PAREF-NORTHFIELD SCHOOL FOR BOYS, INC., A NON-STOCK, NON-PROFIT CORPORATION DULY ORGANIZED UNDER PHILIPPINE LAWS, REPRESENTED BY THE SCHOOL BOARD CHAIRMAN, FELIX Y. MABANTA, JR., FOR THE DEVELOPMENT OF A PARCEL OF LAND OWNED BY THE QUEZON CITY GOVERNMENT CONTAINING AN AREA OF THIRTY-ONE THOUSAND SIX HUNDRED EIGHTY-NINE (31,689) SQUARE METERS, MORE OR LESS, INTO A PARK WITH A SCHOOL PARTICULARLY NORTHFIELD SCHOOL FOR BOYS.

WHEREAS, on February 28, 2001, pursuant to the authority granted by the City Council, thru Resolution No. SP-1454, S-2000, adopted on September 19, 2000, the Honorable City Mayor Ismael A. Mathay, Jr., entered into a Memorandum of Agreement to develop a parcel of land owned by the Quezon City government into a Park with a school, with Paref-Northfield Schools for Boys, Inc., a non-stock, non-profit corporation duly organized and existing under the Laws of the Philippines, represented by its School Board Chairman, Mr. Felix Y. Mabanta, Jr., which agreement was entered in the notarial registry of Atty. Eulogio R. Rodriguez as Doc. No. 131, Page No. 28, Book No. III, Series of 2001, copy of which is attached as Annex A;

WHEREAS, the above-mentioned memorandum of agreement appears to be regular in all respect and the same may be ratified by the City Council.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it hereby ratify, the memorandum of agreement entered into by the Honorable City Mayor Ismael A. Mathay, Jr., with Paref-Northfield School for Boys, Inc., a non-stock, non-profit corporation duly organized under the Philippine Laws represented by Felix Y. Mabanta, Jr., School Board Chairman for the development of a parcel of land owned by the Quezon City Government containing an area of Thirty One Thousand Six Hundred Eighty Nine
