A RESOLUTION ENDORSING THE DEVELOPMENT AND GRANT OF INFORMATION TECHNOLOGY (IT) ZONE FOR THE ARANETA CENTER OWNED AND/OR OPERATED BY ARANETA CENTER INC. AND LOCATED IN BARANGAY SOCORRO IN QUEZON CITY, SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS.

Introduced by Councilors GODOFREDO T. LIBAN II, EUFEMIO C. LAGUMBAY, VINCENT P. CRISOLOGO, RAMON G. MATHAY and JORGE L. BANAL.

WHEREAS, the Araneta Center Inc., is applying for IT Zone status for the Araneta Center from the Philippine Economic Zone Authority (PEZA) and is seeking a favorable endorsement from the Sangguniang Panlungsod of Quezon City, necessary for the grant/approval of the propose IT Zone status for the Araneta Center,

WHEREAS, the proposed IT Zone status for the Araneta Center is in accordance with the Metro Centro Quezon City Development Program, which intends to establish a Central Business District located in Cubao, Quezon City, and gives priority status to Information Technology Based Industries as provided in the City Council Resolution No. SP-1512, S-2001;

WHEREAS, the IT Zone status for the Araneta Center will attract new investments to Quezon City in the area of computer and knowledge based operations, such as call centers, shared services, computer animation, computer graphics, solutions providers, and software development;

WHEREAS, these potential investments are skills and labor intensive which will open employment and skills development opportunities for the constituents and residents of Quezon City and also that of its neighboring cities and municipalities.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to endorse, as it does hereby endorse, the development and grant of Information Technology (IT) Zone status through the Philippine Economic Zone Authority for the Araneta Center owned and operated by Araneta Center Inc., and located in Barangay Socorro in Quezon City, subject to all legal existing rules and regulations.
