RESOLUTION NO.: SP- 1563, S-2001

A RESOLUTION AUTHORIZING THE SALE TO COUNCILOR WINSTON "WINNIE" T. CASTELO OF THE MOTOR VEHICLE, A TAMARAW FX MODEL 1993, OFFICIALLY ASSIGNED TO HIM AS CITY COUNCILOR OF QUEZON CITY, AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, the Quezon City government has adopted a policy embodied in Resolution No. 8630, S-71, allowing its officials, officers and employees to purchase some equipment officially assigned to them at the appraised value at the time of sale;

WHEREAS, all members of the City Council of Quezon City have been issued motor vehicles by the Quezon City government for their official use in connection with the exercise of their official functions;

WHEREAS, the sale of the motor vehicle to Councilor Winston T. Castelo, would be beneficial and advantageous to the Quezon City government as it would be a means to recover the funds used in purchasing the said vehicle.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the sale to Councilor Winston "Winnie" T. Castelo of the motor vehicle, a Tamaraw FX Model 1993, officially assigned to him as City Councilor of Quezon City, at a price to be
