# RESOLUTION NO. SP- 15 64-, S-2001

A RESOLUTION TASKING THE CITY ENGINEER TO CONDUCT A STUDY AND MAKE A PROPOSAL TO THE CITY COUNCIL ON THE CRITICAL NEED TO PROVIDE FOR SAFE AND CONVENIENT ACCESS BY PEDESTRIANS TO THE QUEZON MEMORIAL CIRCLE.

Introduced by Councilors JORGE L. BANAL and GODOFREDO T. LIBAN II.

Co-Introduced by Councilors Vincent P. Crisologo, Ma. Fresca M. Biglang-awa, Winston "Winnie" T. Castelo, Eric Z. Medina, Eufemio C. Lagumbay, Marcel C. Rillo and Ramon G. Mathay.

WHEREAS, access by pedestrians to the Quezon Memorial Circle is hampered by the absence of a safe passage, considering the unending, speeding vehicle traffic on the rotunda road;

WHEREAS, the danger of crossing the busy rotunda road discourages families, especially with children and without vehicles, going to the park;

WHEREAS, aside from park visitors, employees of the park and establishments therein are exposed to danger daily as they cross the rotunda road to and from their work;

WHEREAS, in an obvious desire to preserve the architectural landscape of the rotunda road as they relate to the overall landscape of the Quezon Memorial Park, government authorities have resisted constructing overpass therein:

WHEREAS, the public interest equation tilts heavily in favor of safety as against aesthetics, when the two are in conflict;

WHEREAS, aside from overpasses there exist the possibility that a couple of underpasses would serve the purpose of safe and convenient pedestrians access to the park.
