RESOLUTION NO. SP-1570, S-2001

A RESOLUTION AUTHORIZING THE SALE OF THE MOTOR VEHICLE OFFICIALLY ASSIGNED TO VICE MAYOR CONNIE S. ANGELES, AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.
