RESOLUTION NO. SP- 1576, S-2001

A RESOLUTION AUTHORIZING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, TO ENTER INTO A CONTRACT/DEED OF SALE FOR THE ACQUISITION OF A PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 62878 ISSUED IN THE NAME OF CECILIO MENDOZA MARRIED TO ADELA MENDOZA, CONTAINING, MORE OR LESS, TWO THOUSAND (2,000) SQUARE METERS LOCATED AT BARANGAY BAGONG SILANGAN, QUEZON CITY, WHICH WAS USED BY THE CITY GOVERNMENT AS RELOCATION SITE OF DISPLACED FAMILIES IN DAPITAN PUBLIC MARKET, BARANGAY STA. TERESITA, DISTRICT I, QUEZON CITY.

WHEREAS, the City government in 1997 had relocated the displaced families of Dapitan Public Market by using the property of Spouses Cecilio and Adela Mendoza located at Barangay Bagong Silangan, District II, Quezon City, with the assurance that they will be fully compensated;

WHEREAS, the said property which is a parcel of land with an area of Two Thousand (2,000) square meters covered by Transfer Certificate of Title Numbered 62878 issued by the Register of Deeds of Quezon City in the name of Spouses Mendoza, has been occupied by the relocatees for so many years, but the registered and lawful owner of the property remains unpaid or uncompensated;

WHEREAS, the City government by reason thereof has the legal obligation to pay what is due to the lawful owner of the property and facilitate the payment thereof, hence, there is a need to authorize the local chief executive to enter into a contract/deed of sale in consonance with Republic Act No. 7160.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Mayor Ismael A. Mathay, Jr., City Mayor, to enter into a Contract/Deed of Sale for the acquisition of a parcel of land covered by Transfer Certificate of Title Numbered 62878 issued in the name of Cecilio Mendoza married to Adela Mendoza, containing, more or less, Two Thousand Square Meters (2,000) located at Barangay Bagong Silangan, Quezon City, which was used by the City government as relocation site of displaced families in Dapitan Public Market, Barangay Sta. Teresita, District I, Quezon City.
