RESOLUTION NO. SP 1 5 77, S-2001

A RESOLUTION AUTHORIZING THE SALE TO MR. ANTONIO S. LAUDICO, ASSISTANT SECRETARY TO THE MAYOR AND OFFICER-IN-CHARGE, CITY GENERAL SERVICES OFFICE, THE MOTOR VEHICLE ASSIGNED TO HIM AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

Introduced by Councilor GODOFREDO T. LIBAN II.

WHEREAS, a motor vehicle was issued and assigned to Mr. Antonio S. Laudico being the Assistant Secretary to the Mayor and Officer-in-Charge of the City General Services Office;

WHEREAS, Quezon City Resolution No. 8630, S-71, authorizes the sale to officials, officers and employees of the Quezon City government of vehicles presently assigned to them, should they be willing to purchase the same at their appraised value at the time of the sale provided that taxes payable and due the government shall be shouldered by the purchaser;

WHEREAS, Mr. Laudico manifested his intention to buy the abovementioned motor vehicle assigned to him.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the sale to Mr. Antonio S. Laudico, Assistant Secretary to the Mayor and Officer-In-Charge, City General Services Office, the motor vehicle assigned to him at a price to be determined by the city appraisal committee, subject to existing auditing rules and regulations, details of said vehicle is hereunder stated:
