SEV-927, AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

WHEREAS, Quezon City Resolution No. 8630, S-71, authorizes the sale to officals, officers and employees of the Quezon City government of vehicles presently assigned to them, should they be willing to purchase the same at their appraised value at the time of the sale provided that taxes payable and due the government shall be shouldered by the purchaser;

WHEREAS, the sale of said vehicle to Ms. Rances who had been using the same for here official functions would be beneficial and advantageous to the Quezon City government considering the amount that may be derived from such sale.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable City Mayor of Quezon City to sell to Ms. Lourdes S. Rances, City Finance Coordinator, the motor vehicle assigned to her as the implementor of the Scholarship and Youth Development Program at a price to be determined by the City Appraisal Committee, subject to existing auditing rules and regulations, details of said vehicle is hereunder stated:
