WHEREAS, Atty. Lourdes P. Santos assumed the duties of her position as Secretary to the Mayor Ismael A. Mathay's administration from July 1, 1992 to June 30, 2001 for a period of nine (9) successive years;

WHEREAS, in the performance of the said duties, Atty. Santos has brought with her broad knowledge and keen insight in local governance gained from her experiences in the government service at the local (Metropolitan Manila Commission) and national (Department of Agriculture) levels, at the legislative branch (Senate of the Philippines & House of Representatives) and at an independent constitutional body (Commission on Audit) where she worked as a lawyer and administrator in various capacities;

WHEREAS, as Secretary to the Mayor, she has successfully collaborated and coordinated with the City Council in the enactment and passage of critical and important measures relating to the City Mayor's priority projects such as the Smile City Homes; Sitio Mendez Housing project, the construction of the Dapitan Public Market under a Build-Operate and Transfer scheme, the Medicap and St. Luke's Medical Assistance program, to mention just a few;


WHEREAS, during her brief stint as head of the Barangay Operations Center, she recommended and secured the approval of the City Council of an ordinance establishing a city-wide Barangay Day on 25 June of every year which has become a traditional Recognition Day of our Barangay Captains and other officials who have rendered dedicated and exmpalary services to their respective barangays;

WHEREAS, as Secretary to the Mayor, she has always exerted efforts to act with dispatch, fairness, humanism and commitment to public service in dealing with the clientele of her office - the city personnel, the barangay officials and the needy sector of the city's constituency;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to express, as it does hereby express, the council's gratitude and appreciation to Atty. Lourdes P. Santos for her unselfish, untiring and dedicated service to the Quezon City government as Secretary to the Mayor for nine (9) successive years.
