RESOLUTION NO. SPT 596, S-2001

A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE HONORABLE MAYOR ISMAEL A. MATHAY, JR WITH ISH CONSTRUCTION, INC. FOR THE RENOVATION OF THE OFFICE OF THE COMMISSION ON AUDIT LOCATED AT THE FIRST AND SECOND FLOORS OF THE QUEZON CITY HALL ANNEX AND APPROPRIATING THE AMOUNT OF THREE MILLION EIGHT HUNDRED TWELVE THOUSAND EIGHT HUNDRED EIGHTY-SIX PESOS & 49/100 CENTAVOS (P3,812,886.49) FUNDED UNDER THE OFFICE OF THE MAYOR.

WHEREAS, the existing office of the Commission on Audit is in a deplorable condition specifically the ceiling, wall partitions, flooring, tiles, doors, electrical and plumbing systems whereby endangering the lives and properties of the dwellers particularly the employees of the said office;

WHEREAS, due to the said condition of the office, there is a strong appeal by both the employees and public conducting business with the offices of the Commission on Audit;

WHEREAS, due to the nature of business and mandated functions of the office of the Commission on Audit in maintaining and upkeep of the book of audits for all funds maintained by the City and its 142 barangays, there is a need for an assurance for the place/office to be always in safe conditions;

WHEREAS, the present deplorable condition of the offices of the Commission of Audit has caused inconvenience for the employees and the public thereat which necessitates the immediate renovation of the said offices;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the contract entered into by the Honorable Mayor Ismael A. Mathay, Jr with ISH Construction, Inc. for


