RESOLUTION NO. SP-1599, S-2001

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR OF QUEZON CITY TO SELL TO HONORABLE ANTONIO L. SIOSON THE MOTOR VEHICLE, PARTICULARLY INDENTIFIED AS TOYOTA TAMARAW FX WITH PLATE NO. SEK-173 BEING USED IN HIS VARIOUS OFFICIAL FUNCTIONS AS CITY COUNCILOR OF QUEZON CITY AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING RULES AND REGULATIONS.
