RESOLUTION NO. SP 1600, S-2001

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SEA OIL PETROLEUM CORPORATION FOR THE CONSTRUCTION OF TWO GASOLINE SERVICE STATIONS IN EDSA AND CULIAT, QUEZON CITY.

WHEREAS, petitioner Seaoil Petroleum Corporation is embarking on an expansion of its gasoline filling stations and has requested the Quezon City Council for the issuance of a Special Use Permit for the construction of two (2) gasoline service stations to be situated at the following areas:

1. No. 843-845 E. de los Santos Avenue, Brgy. South Triangle, Diliman, Quezon City.
2. Don Antonio Avenue, Don Enriquez Heights, Brgy. Culiat, Quezon City

WHEREAS, the construction and establishment of the gasoline service stations is beneficial to the general public and that the proposed sites conform with the list of permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992" and its implementing rules and regulations through an appropriate measure passed by the City Council authorizing the construction thereof.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to SEA OIL PETROLEUM CORPORATION for the construction of two (2) gasoline service stations to be situated at the following areas:


