RESOLUTION NO. SP-1801, S-2001

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO FLYING V FOR THE CONSTRUCTION OF A GASOLINE SERVICE STATION ALONG COMMONWEALTH AVENUE, DON JOSE HEIGHTS, QUEZON CITY, ON THE PARCEL OF LAND COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. N-222292, N-222293, N-222294 AND N-222295.

WHEREAS, the petitioner FLYING V is embarking on an expansion of its filling stations and has requested the issuance of a Special Use Permit for the construction of a gasoline service station along Commonwealth Avenue, Don Jose Heights, Quezon City on the parcel of land covered by Transfer Certificates of Title Nos. N-222292, N-222293, N-222294 and N-222295;

WHEREAS, the construction and establishment of the gasoline service station in the above-stated area is beneficial to the general public and that the proposed site conforms with the list permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992", and its Implementing Rules and Regulations through an appropriate measure passed by the City Council authorizing the construction thereof.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special use Permit to FLYING V for the onstruction of a gasoline station along Commonwealth Avenue, Don Jose Heights, Quezon City on the parcel of land covered by Transfer Certificate of Title Nos. N-222293, N-222293, N-222294 and N-222295.
