# RESOLUTION NO. SP\_1611, S-2001

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SELL TO COUNCILOR NANETTE CASTELO DAZA OF THE MOTOR VEHICLE ASSIGNED TO HER PARTICULARLY DESCRIBED AS TOYOTA TAMARAW FX WITH PLATE NO. SEG 454, BEING USED IN HER VARIOUS OFFICIAL FUNCTIONS AS CITY COUNCILOR OF QUEZON CITY AT A PRICE TO BE DETERMINED BY THE CITY APPRAISAL COMMITTEE, SUBJECT TO EXISTING AUDITING RULES AND REGULATIONS.

## Introduced by Councilor GODOFREDO T. LIBAN II.

WHEREAS, Section 16 of the Local Government Code of 1991 authorizes the Quezon City to enact reasonable and wholesome measures that would promote the welfare of the inhabitants of the city;

WHEREAS, all city councilors have been issued motor vehicles by the Quezon City Government for their official use in connection with the exercise of their official functions;

WHEREAS, the sale of the assigned motor vehicle to Councilor Nanette Castelo Daza would be beneficial and advantageous to the Quezon City Government as it would be a means to recover the funds used in purchasing the said vehicle instead of putting additional funds for the acquisition thereof.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, Honorable Ismael A. Mathay, Jr., City Mayor, Quezon City, to sell to Councilor Nanette Castelo Daza of the motor vehicle assigned to her particularly described as Toyota Tamaraw FX with Plate No. SEG 454, being used in her various official
